Patient Screening Log - Completion Instructions

^a Reasons for ineligibility:

- A = There is a major/life-threatening congenital malformations in neonate (e.g. chromosomal anomalies, Fanconi's anaemia, Thrombocytopenia Absent Radius syndrome).
- B = The occurrence of a major/ severe bleed within the previous 72 hours. (The neonate may be eligible for randomisation later, once 72 hours has elapsed, provided there are no further major bleeds and the baby meets all the other inclusion criteria). If this is the case, simply annotate the entry on the form to say now eligible.
- C = The occurrence of any significant fetal intracranial haemorrhages excluding subependymal haemorrhage from any antenatal ultrasound scan.
- D = There is a known immune thrombocytopenia or family history of alloimmune thrombocytopenia or maternal antiplatelet antibodies or maternal idiopathic thrombocytopenic purpura
- E = The neonate is judged by the attending neonatologist to be unlikely to survive more than a few hours at the time of proposed randomisation.
- F = The neonate was not given parenteral Vitamin K after birth.
- G = It was not possible to undertake cranial ultrasound scan within 6 hours prior to predicted randomisation

^b If Eligible for trial, but parents / guardians not approached, is it because:

- A = Platelets recovered above 100 before being approached for consent
- B = Parents were considered too upset at time to ask by attending clinician. This may change, and if baby still eligible, please annotate on log and proceed to approach for consent.
- C = Baby transferred in to unit for short period, such as a procedure and then to be discharged back to a non-participating unit.
- D = Baby 'missed' (eg no member of research team were available for screening). This is therefore to be completed retrospectively
- E = Other. Could you elaborate in a few words?
